Term of Agreement:

The term of this Agreement will begin on the date executed and continue in full force and effect for Three Years, at which point and Agreement shall terminated unless extended by mutual agreement of the parties,

1. Emergency Situations:

The Hospital hereby agrees to extend all cadets, hassle-free immediate Admission on Emergencies, on presentation of a valid ID card or by follow up with the Delta Squad.

JM Hospital shall provide prioritized medical attention only on Doctors discretion.

JM Hospital shall also provide Ambulance services on emergencies.

2. Out – Patient Treatment:

The Hospital agrees to provide hassle free outpatient treatment for the Cadets of Delta Squad of a valid ID card or by follow up to the Delta Squad team.

The Parties agree that both the Hospital and Delta Squad are independent organizations and this agreement shall not be construed to create an agency relationship or a joint venture relationship between the parties to the Agreement and their respective employees, agents and assigns, Hospital shall not have any control over the manner or method by which Delta Squad performs its professional duties or responsibilities and vice versa. Also, it is the sole responsibility of the hospital to provide any referenced regulatory or compliance documents to Delta Squad for review as may be required if the situation warrants.

All the bills and payments will be covered by the Delta squad within the stipulated time period as agreed by the both parties.

4. Notices:

All notices, requests, demands, and other communications required or permitted hereunder shall be in writing and shall be deemed to have been duly delivered if delivered in person or sent by registered or certified, first class mail, postage prepaid to Delta Squad, Registered office at 62 ward no: 18-29 VK Krishnan Road, Coimbatore South Siddhapudur Coimbatore, Tamil Nadu- 641 044
