Here in after referred to as the Main Trustees of "WOMEN ASSOCIATION FOR SUSTAINABILITY AND HORMONY" having its registered office at Kothandaramapuram, Kamarajar Nagar, Thondamanatham (Post), Cuddalore Taluk. 607301, Cuddalore District, Tamil Nadu. Which expression on shall wherever the context to admits include the servivers of them and the administrator and executors of the last survivers of them, and the administrators and executors of the survivers of the last trustees or Trustees for the time being of trust hereby created.

- 2. OBJECTS of the Trust shall be :-
- (a) to provide, establish, maintain, run, develop, improve, extend, grant, donation for and to aid and assist in the establishment maintenance, running, evelopmnt, improvement and extention of Hospital, clinics, Dispensaries, Maternity Homes, Leper Homes, Homes for the Blind, Deaf and dumb as well as those mentally retarded and similar institutions affording treatment.
- (b) to establish, maintain, run, develop, grant donations and to aid in the establishment maintenance, running, development, improvement and extension of libararies, reading rooms, recreation centres and other facilities as are calculated to be of use in imparting education to the Women, Children in formal and Non-formal education.
- (c) to build, errect and construct and to aid and assist in building errection and construction of houses, teneants and places of residence for the poor, destitutes and those handicapped in mind or body and to afford them all conforts and ammenities.

- (d) to conduct poor feeding and to give food, clothing and cash grants to the poor and to afford relief to people ain distress and affected by earthquake, flood, famine, pestilence and other causes and to grant donations for the support of the inmates of orphanages rescue houses and smiliar institutions and organisations.
- (e) to provide cash and other forms of relief to the orphans without adequate means of sustinence, the poor for education of their Children, their medical needs etc., And on the occassions of death, etc in their families and those who suffered in accidents.
 - (f) to plan self-employment programmes, Health care activities for women.
 - (g) to work for the appropriate technology trasfer to women.
 - (h) to give vocational skill training and career building services to women and to equip them for self-employment.

- (i) to run career quidance cell, encourage for advanced studies.
- (j) to give education for liberation to women.
- (k) to fulfill all economical development schemes for women.
- (I) to solve the problem of women through women counselling centres.
- (m) to achieve special progressive schmes to helpless and the disabled.
- (n) to provide fundamental education and higher education for women.
- (o) to give trainings in micro-enterprises and women progress.
- (p) to link the government schmes and to help them with the proceedures.
- (q) to experiment environment friendly agriculture and new technologies.

- (r) to eliminate rural women unemployment through economic, social educational programmes.
- (s) to start rehabilitation centres, schools and educational institutions for higher education.
- (t) to undertake awareness programmes on Aids/HIV and other health care and mother and child care activities. And whereas the authors of the trustees of the trust has endowed and set apart a sum of Rs.1000/- (Rupees one thousand only) as an initial endowment to the corps in this behalf.

OFFICE:

The registered office of, "WOMEN ASSOCIATION FOR SUSTAINABILITY AND HORMONY" shall be at Kothandaramapuram, Thontamanatham post - 607 301. It shall have brach offices in other places wherever required as may be decided by the trustees.

MANAGEMENT:

The management of the "Women Association for Sustainability and Hormony" shall be vested in a Board of Trustees having seven trustees including the managing trustee who will have a casting vote, in case of a tie. The Board of Trustees can appoint new members and accept the resignation of any members. The quorum will be a minimum of two members. All committies and departments will be resposible to the Executive Committee which in trun will be responsible to the board of Trustees.

- 5. The financial year of the Trust shall end on 31st March every year.
- 6. The trustees may accept any donation, contribution in cash or in kind from any person, firm, company corporation association, institution or trust including the founder for the furtherance of the object of the Trust or for any one or more of them in India.

F. Saluaganabatty

- 7. The trustees shall cause true and accurate to be kept of all maneys received and spend and of all moneys received matters in respect of the Trust properties.
 - 8. The trust irrevocable.
- 9. It is open to the trustees to add to suppliment the objects of this trust provided. However they shall be charitable in nature and be written the ambit of the objects for which the Trust is established viz for the charitable purpose as defind in the income tax act.
- 10. The following shall be the Trustees of the Trust and shall constitute the Board of Trustees for this trust. 1. Mr. E. Selvaganapathy, 2. T. Kavitha, 3. S. Karpagam, 4. M. Karthigai valli, 5. R. Rajalakshmi
- 11. The board of trustees shall be at liberty to raise funds by collecting sale sub scriptions and donations or by other practical means. In Feature At present Subscription not subscribed from trustee and others.
- 12. The board of trustees shall be entitled to open and maintain a bank account or accounts at a such bank or banks as the trustees may from time to time decide and may at any time pay or cause to be paid any moneys to the credit of any such account or accounts and either by way of fixed deposit or current account or any other account. Any such account may be operated by the Trustees.
- 13. The trustees shall invest the trust and all moneys of the Trust which may require investment in or opon any one or more of the following securities or more of investment with power from time to time at their descretion very any investment and securities held by the trustees for others of the character hereby authorised
- (a). anys tock or securities issued by the interest of which government of any state in India.
- (b). fixed or other deposits with any scheduled bank or banks or with any public sector company registered in India as prescribed by Income Tax Act.

- (c) Any immovable property or lease hold interest there in or flat on ownership basis.
- (d) Any category of investment in which the trustees are the law or the time being in free in the union of India authorised to invest such moneys
- 14. No funds or other property of the trust shall be paid to or dis tributed among the trustees but shall be applied towards the furthrance of the trustees, objects or for any charitable purposes. In the event of dissolation the funds remaining shall be devoted to object similar to those of the trust. The trustees shall have the power to borrow or raise moneys in such anner as the trust shall think fit.
- 15. The trustees shall be entitled to institute conduct defent or abandon any legal proceedings by or against the trust or it's office bearers or otherwise concerning a the affairs of the trust.
- 16. The trustees shall be entitled to accept any voluntary contributions made with a specific direction thay they shall from part of the corporations of the trust in which even the same shall be held.
- 17. The accounts shall be kept of the moneys received and expended by the trust and of the properties are dits liabilities of the trust. The accounts of the trust shall be audited by a charatered accountant appointed by the Trustees.
- 18. The board of trustees shall framed rules for the requiation of the conduct of the administration of the trust and the trustees shall have power to around or vary or alter or add to these rules subject. However the rules framed shall be in accordance with and consistant with the objects for which the trust is established.

F. Salwagnabalty

- 19. The trust consists or a well learned persons with a sense of citizenship price in profession and dignity of labour. The members of the trust are men of honesty and integrity and socially highly repectable persons. They have enough means and men to raise necessary fund or the institution whatever the sureties and solvancies required in this connection would be met by the Trust.
- 20. The trust proposed to expect it's activities after successfully extablishing this institution on a sound and healthy footing.
- 21. Power of the trustees: The Trustees shall have all the powers necessary or incidental for effectually carried out the object of the Trust. Subject to the general provisions of the Trust and without prejudice to the general and specified powers conferred upon the trustees by the other provisions contained in these presents the trustees shall have the following also.
 - 1. To apply the trust moneys effectute one object some of the objects of the trust in preferance to the other objects.
 - 2. To discontinue the application or trust funds, to the object and divert the funds to another object.
 - 3. To decide the nature, objects and functions of the institute to be established by the trust and to decide whether and it so existing institution or institutions may be late over by the Trust or to which financial aid may be given.
 - 4. In case it is decided to render financial or other aid to any person or institution to decide what terms and conditions shall complied with by such institutions.

E. Salvagangbathy

- 5. To acquire build upon, pull down, rebuiled and to after repair improve, sell or dispose of any land building or premises for the use of the Trust and to acquire other movable or immovable properties. In feature.
- 6. To lets any property on lease of hire.
- 7. At present there is no movable and immovable property in the name of trust except Rs. 1000/- stated above
- 8. To let on hire or lease or otherwise any movable or immovable properties not immediate required by the Trust. In feature.
- 9. To acquire any property is exchange for some other property partly in such exchange and party for other consideration. In feature
- 10. To borrow any money upon the security of any of the properties of the Trust and to grant mortgage for security the same without any security and upon such terms and conditions that the Trustees may deem fit.
- 11 To settle out of the court compromise and compound all suits, actions and other proceedings and all differences or demand to arbitration and to execute release and to a settle and approve all acounts without being answerable any less occasioned thereby.

E. Schoganghatty

- 12. To appoint and dismiss managers, securtaries clerks and the staff and workers required for working and for general management of the affairs of the Trust. The managing Trust ees shall act as chairman of the Board of Trustees, the chairman shall have a casly vote in the case quality of vote.
- 13. The trustees shall hold such meetings as may from time to time be necessary for cosidering any matter connected with the Trust that may be held at such places as the Trustees may decide so however there shall be atleast one meeting of the Board of Trustees in financial years.
